Specific Membership Guidelines of the National Committee on Southern Cultural Communities"

Membership to the National Committee on Southern Cultural Communities (NCSCC) shall be institutional, to represent major cultural communities identified based on ethnic distribution. The members of the NCSCC should represent a legitimate community-based Indigenous Peoples (IP) organization such as People's Organizations, and Non-Government Organizations representing/ working for the cultural communities, and properly recognized and endorsed by the said organization.

The members of the National Committee on Southern Cultural Communities must: 1) be based in the community; 2) be knowledgeable of the culture including the language of the indigenous peoples being represented; 3) have a bloodline as a member of the cultural community; 4) practises the cultural traditions; 5) have good moral ascendancy; 6) have commitment, dedication and ample time to serve the Committee (includes active participation in Committee meetings, involvement in local cultural activities, and assistance in implementation and liquidation of projects); 7) be at least High School graduate; and 8.) be in good health condition (with medical certificate); For cultural leaders and workers (including cultural administrators, researchers, culture bearers, artists and practitioners) aspiring to become a member of the NCSCC, one must be actively working for the protection, promotion and development of the cultural communities and traditional arts.

The Executive Council consists of fifteen (15) members from the legitimate community-based IP organizations representing but not limited to the following cultural communities from Regions IX, X, XI, XII, CARAGA and ARMM:
