Thereby Rescinding Resolution 2007-304


RESOLVED, as it is hereby RESOLVED, To approve the Specific Membership Guidelines of the National Committee on Museums, herewith attached as Annex A;

NATIONAL COMMITTEE ON MUSEUMS

Membership to the National Committee on Museums (NCOM) is institutional in nature. It is composed of museum-based individuals who are representatives of public and private museums including regional museums and who are involved in all aspects of museum work and other museum-related activities.

The Executive Council (ExeCon) shall consist of thirteen (13) members who are the officially designated representatives of the following institutions/organizations.

- Two (2) from the Government Cultural Agencies (Ex-Officio), i.e., the National Museum (NM) and the National Historical Commission of the Philippines (NHCP)

- Eleven (11) representatives from regional museum associations:
 1. Northern Luzon Association of Museums (NLAM)
 2. Southern Luzon Association of Museums (SLAM)
 3. Bicol Association of Museums (BAM)
 4. Central Luzon Association of Museums (CLAM)
 5. Western Visayas Association of Museums (WVAM)
 6. Visayas Association of Museums and Galleries, Inc. (VAMGI)
 7. Eastern Visayas Association of Museums (EVAM)
 8. Mindanao Association of Museums (MAM) [2 representatives]
 9. National Capital Region Association of Museums (NCRAM) [2 representatives].

It is highly encouraged that the designated regional museum association representatives shall come from private museums.

All the ExeCon members shall hold office for a term of three years, and are eligible for election to a 2nd term, but shall not serve for more than two consecutive terms. Any ExeCon member who had served the committee for two consecutive terms may vote but will no longer be eligible to be nominated as member of the Executive Council.

All ExeCon members must be officially confirmed in writing by NCCA.
