NOTICE OF 3RD CONFERENCE

IN RE: CASE NO. NCCA-3-2015-9 Titled: “CEASE AND DESIST ORDER ON THE IMPLEMENTATION OF THE INFRASTRUCTURE PROJECT ALONG THE DAANG MAHARLIKA (NATIONAL HIGHWAY) IN THE MUNICIPALITY OF SARIAYA, PROVINCE OF QUEZON”

The instant case was referred for conference by the Hearing Officer Atty. Ahmed George Paglinawan to facilitate alternative means of resolving the issue.

In today’s conference the parties were represented by Mr. Cenon Allan Loria, the municipal administrator, and Mr. Marion Saligay, for the Local Government of Sariaya Quezon; Atty. Edward Mananes, Engr. Wilfredo Recelis and Engr. Aiza Manalastas, for the Department of Public Works and Highways (DPWH); and finally, Atty. Agatha Zapantha- De Jesus, cultural prosecutor, and Ms. Rina Marques, one of the owner of the properties along the Daang Maharlika, Sariaya Quezon.

In the discussion, parties agreed to the following:

1. That the **DPWH** will **SUBMIT** to the NCCA secretariat and to the undersigned conference officer the revised plans for the project along the Daang Maharlika, in Sariaya, Province of Quezon, in the area where the affected heritage houses are and also the streetscapes, provided that all other parties shall be furnished with the aforementioned revised plans not later than a week from today’s conference;
2. That the revised plan of the DPWH for the Daang Maharlika project will be **POSTED** in the bulletin board, together with this **NOTICE**, of the Municipal Hall of Sariaya, Quezon, the NCCA Bulletin Board and the NCCA Website for **fifteen (15) consecutive days**. Within the said period we will entertain intervenors but limited only to those who are owners, administrators, care-takers, or occupants;
3. Upon the lapse of the fifteen (15) day posting period, another conference meeting will be conducted and to be held in the Municipality of Sariaya. Venue is to be provided by Ms. Rina Marquez, herein petitioner.

Wherefore, let it be resolved that the next conference meeting In Re: Case No. NCCA-3-2015-9, is tentatively set on **September 14 & 15, 2015 at 2:00 pm** at the venue to be provided by Ms. Rina Marquez.
