**2.** <u>**Reservation Clause.**</u> NCCA, as the auctioneer, including its employees (except the Members and Secretariat of the NCCA Disposal Committee) reserves the right to bid on any unit.

**3.** <u>**Requirements**</u>. During the opening date (12 November 2019), the prospective bidder shall present the original copy of the following to the Registration desk:

3.2. Acknowledgement Receipt of Bid Bond.
