1. CALL TO ORDER

The meeting was called to order by the presiding officer at 1:10 PM upon determination of a quorum.

2. ADOPTION OF THE PROPOSED AGENDA

With no objection, the Board adopted the proposed agenda as amended.

3. REPORT OF THE EXECUTIVE DIRECTOR

3.1 Minutes of the July 8, 2020 Commission Meeting

With no objection, the Board approved the Minutes of the July 8, 2020 meeting as presented.

4. BUSINESS ARISING FROM THE MINUTES OF THE JULY 8, 2020 REGULAR COMISSION MEETING

4.1 Request for an Official Statement of NCCA Supporting Bohol as the Site for the Regional Cultural Hub

The secretariat clarified that Bohol is one of the three pilot regional culture hubs of the NCCA along with Davao and Sorsogon. The NGO (Bohol Integrated Development Foundation, Inc. [BIDF]) was the partner of the Provincial Government of Bohol in the preparation of the necessary architectural plans, study and research to be used by the LGU in seeking for the funding requirement for the hub. The funding from the NCCA was used for the masterplan. The said amount was directly released to BIDF, the group commissioned by the NCCA and the LGU.

A copy of RDC Central Visayas Region Resolution No. 63 (S. 2018) titled, "Endorsing to the National Commission on Culture and the Arts (NCCA) the conduct of a Feasibility study for a Regional Cultural Hub including an institute of Living Traditions, and their establishment in the Province of Bohol" was presented to the board.

4.2 Update on the Rehabilitation and Conservation of the Metropolitan Theater Project

Revision to Board Resolution No. 2020-309 on the Delegation of Authority/ Update on Project Implementation-Administrative Matters

Concerning the Metropolitan Theater, the following resolutions were passed by the board:

WHEREAS, the Metropolitan Theatre (MET), a National Cultural Treasure declared by the National Museum (NM), and a National Historical Landmark declared by the National Historical Commission of the Philippines (NHCP), is a property of the National Commission for Culture and the Arts (NCCA), purchased in 2015;

WHEREAS, the NCCA is implementing the "Conservation and Rehabilitation of the Metropolitan Theater (MET) Phase I (Rehabilitation and Conservation of the Main Theater) and Phase II (Rehabilitation and Conservation of the East and West Complex), a major infrastructure project of the Commission;

WHEREAS, the NCCA Board of Commissioners approved Board Resolution No. 2020-309 datedFebruary 20, 2020, "Delegation of authority to the Executive Director to Act and Decide on Matters Concerning the Implementation of the Rehabilitation of the Metropolitan Theater";

WHEREAS, with the engagement of a full-time Project Manager in coordinating the day-to-day operation of the Rehabilitation and Conservation of the Metropolitan Theater, there is a need to update and revise the said delegation schedule in order to streamline the performance of work in the project;

NOW THEREFORE, be it **RESOLVED,** as it is hereby **RESOLVED**. That the new delegation of authority for activities related to the implementation of the projects related to the Metropolitan Theater are adopted, as contained in Annex "A" of this resolution;

RESOLVED FURTHER, that all previous delegations are hereby rescinded;

RESOLVED FURTHER, that in the absence of the designated officials, their Officer-in-Charge and/or Deputies shall be authorized to sign the same on their behalf;

RESOLVED FURTHER, that in the exigency of the service while on community quarantine, electronic signatures duly attached by the respective officers shall be accepted as equivalent to signature made by the same;

RESOLVED FURTHER, that other documents requiring approval and is not listed in the attached schedule shall be referred to the Executive Director, by default;

RESOLVED STILL FURTHER, that all units/offices of the NCCA Secretariat are hereby directed to extend support to the implementation of the project;

RESOLVED FINALLY, that all issuance inconsistent with this Board Resolution, including Board Resolution No. 2020-309, are hereby revoked or modified accordingly.

Resolution No. 2020-330 Designating the Chairman, Arsenio J. Lizaso as Artistic Director of the Metropolitan Theater

WHEREAS, the Metropolitan Theatre (MET), a National Cultural Treasure declared by the National Museum (NM), and a National Historical Landmark declared by the National Historical Commission of the Philippines (NHCP), is a property of the National Commission for Culture and the Arts (NCCA), purchased in 2015;

WHEREAS, the NCCA is implementing the "Conservation and Rehabilitation of the Metropolitan Theater (MET) Phase I (Rehabilitation and Conservation of the Main Theater) and Phase II (Rehabilitation and Conservation of the East and West Complex), a major infrastructure project of the Commission;

WHEREAS, the theater is projected to be operational by CY 2021;

WHEREAS, in preparation for the theater's opening, there is a need to plan, conceptualize and implement the cultural and artistic program for the inaugural year or season:

WHEREAS, in view of his stature in the arts and culture community, extensive background in the performing arts and broad experience in cultural facilities management, the Chairman was designated by the Board of Commissioners as Artistic Director of the Metropolitan Theater in its meeting on September 17, 2020;

NOW, THEREFORE, be it **RESOLVED,** as it is hereby **RESOLVED**, To Designate the Chairman, Arsenio J. Lizaso as Artistic Director of the Metropolitan Theater (MET);

RESOLVED FURTHER, That as Artistic Director, Chairman Lizaso shall act as the point person and shall take the lead in the cultural and artistic programming of the MET for the inaugural year/season or until the end of his term as chairman of the Commission;

RESOLVED FINALLY, that the Chairman is given the authority and free hand to form and organize a team to assist him in his duties and responsibilities as Artistic Director and to run the Metropolitan Theater.

Resolution No. 2020-331

Approving the Donation to the LGU of Sorsogon City of the Audio System/Equipment Purchased for the Metropolitan Theater in CY 2010 as well as other equipment and materials that may deemed donated for use of cultural hub/center in Sorsogon City

WHEREAS, pursuant to Board Resolution No. 2019-301, the Board of Commissioners approved in principle to donate or transfer the audio system, theater seats and other properties in the Metropolitan Theater (MET) which may no longer be compatible with the upgraded facilities of the theater, to other government agencies, institutions or another property of the National Commission for Culture and the Arts (NCCA) that may be able to utilize the same in the furtherance of the NCCA's mandate to promote and advance creative excellence;

WHEREAS, pursuant to Board Resolution No. 2019-343, the Board of Commissioners approved the disposal of the audio system/equipment purchased for the MET in CY 2010;

WHEREAS, the audio system/equipment was not operationalized as it was supposed to be installed after the conservation of the MET, but it has remained idle because of the discontinuation of the project "Continued Conservation Work of the Metropolitan Theater";

WHEREAS, the Commission on Audit (COA) Resident Auditor, issued Audit Observation Memorandum No. 13-004 dated February 20, 2013 recommending that Management require the Board of Commissioners to pass a resolution for the transfer or donation to other government agencies with the capability to use and preserve the furniture and fixtures and technical and scientific equipment in their operations. The said FFTSE which include the audio system/equipment, intended for use in the MET, were not used in the operation or have been idle since its acquisition in CY 2010;

WHEREAS, the MET Technical Working Group had assessed that the audio system/equipment purchased in CY 2010 intended for the MET is no longer compatible with the design of the theater and would not be able to support performances employing new technology, and may therefore be donated to other government or NCCA partner entities who may be in need of such equipment and fixtures;

WHEREAS, the Board of Commissioners in its meeting on August 29, 2019 expressed interest to donate the audio system/equipment for use in the Sorsogon Cultural Center / Hub:

WHEREAS, the Board of Commissioners in its meeting on September 17, 2019 agreed to donate the audio system/equipment as well as other equipment and materials that may be deemed donated for use of the cultural hub / center in Sorsogon City;

WHEREAS, the NCCA Disposal Committee and the Metropolitan Theater Secretariat shall finally recommend all the materials and equipments to be donated upon final review and assessment;

WHEREAS, the LGU of Sorsogon City is currently undertaking the building and establishment of the Sorsogon Cultural Hub/Center, one of the three pilot regional cultural

hubs of the NCCA, to be located on a parcel of land in Sorsogon City as have agreed by and between the LGU of Sorsogon City and the NCCA;

WHEREAS, NCCA is a government agency mandated ensure the decentralization of opportunities for creative expression through the establishment of local culture art centers in various regions, with resources needed for artistic cultural activities;

WHEREAS, NCCA and LGU of Sorsogon City, in the spirit of cooperation among government agencies, are willing and capable to undertake this partnership in order to jointly support the development of local artistic expressions;

NOW, **THEREFORE**, be it **RESOLVED**, as it is hereby **RESOLVED**, To **Approve** the **Donation to the LGU of Sorsogon City** of the Audio System/Equipment Purchased for the Metropolitan Theater (MET) in CY 2010 as well as other equipment and materials that may be deemed donated for use of the Sorsogon Cultural Hub/Center in Sorsogon City;

RESOLVED FURTHER, To Approve the execution of a Deed of Donation and other necessary legal documents to effect and facilitate the donation to the City of Sorsogon through incumbent Mayor Ester E. Hamor and the NCCA Executive Director of the audio system/equipment purchased for the MET in CY 2010 and other equipment and materials recommended by the National Commission for Culture and the Arts (NCCA) Disposal Committee and the Metropolitan Theater Secretariat / Project Management Team, and approved by the Chairman upon recommendation by the NCCA Executive Director;

RESOLVED FINALLY, that the Chairman and/or the Executive Director are hereby authorized to sign the Deed of Donation and other legal documents for and on behalf of the Commission.

4.3 Guidelines on the Selection and Vetting Process for the Ethnomedicine Category of the Gawad sa Manlilikha ng Bayan

WHEREAS, pursuant to Board Resolution No. 2020-317, the Commission approved the inclusion of the category on Ethnomedicine in the 2020 Call for Nominations for the Gawad sa Manlilikha ng Bayan (GAMABA);

WHEREAS, the GAMABA Executive Council drafted guidelines for consideration of the Commission on the selection and vetting process for the Ethnomedicine category to address the Commission's concern on how to place the said category in national focus

without being misinterpreted as the cure for the on-going public health crisis/COVID-19 and other health concerns:

WHEREAS, the guidelines were adopted from the existing provisions of the Implementing Rules and Regulations of Republic Act 7355 or the Manlilikha ng Bayan Act, and from Republic Act 8423 or the Traditional and Alternative Medicine Act which was specifically crafted to address and accelerate the development of traditional and alternative healthcare in the country;

WHEREAS, the guidelines shall also serve as basis for establishing the anthropological aspect and context of the Ethnomedicine category without disregarding of undermining its scientific aspect;

WHEREAS, the guidelines shall include the definition of terms which shall ensure a common understanding of the vital terms revolving Ethnomedicine category, and provisions in determining members of the Council of Experts that shall assess and evaluate the candidates under the category;

NOW, THEREFORE, be it RESOLVED, as it is hereby RESOLVED,
To Approve and Adopt the Guidelines on the Selection and Vetting Process for the
Ethnomedicine Category of the Gawad sa Manlilikha ng Bayan, herewith attached as Annex B.

5. COMMISSION MATTERS FOR INFORMATION/CONSIDERATION/APPROVAL

5.1 Petition to Declare Philamlife Building as Important Cultural Property

After an extensive discussion, the matter was resubmitted to the Technical Working Council for further review and discussion.

5.2 Proposed Memorandum of Agreement on the Transfer of Regulatory Functions of the National Museum of the Philippines to the National Commission for Culture and the Arts

The board approved the memorandum of agreement between the National Museum of the Philippines (NMP) and the National Commission for Culture and the Arts (NCCA) to provide for the orderly transfer of regulatory functions from the NMP to the NCCA.

[U]pon motion made and duly seconded, the Commission approved this *Resolution:*

Resolution No. 2020–333

Approving the Memorandum of Agreement (MOA) providing for the implementation of Section 30 of Republic Act No.11333,

transferring the regulatory functions of the National Museum of the Philippines to the National Commission for Culture and the Arts and Authorizing the Chairman and the Executive Director

to sign the said MOA for and on behalf of the Commission

WHEREAS, Section 30 of Republic Act No. 11333, otherwise known as the "National Museum of the Philippines Act", provides for the transfer of regulatory functions from the National Museum of the Philippines (NMP) to the National Commission for Culture and the Arts (NCCA), specifically all regulatory functions as provided by Republic Act No. 4846, Presidential Decree No. 260, Presidential Decree No. 374, Presidential Decree No. 1109, Republic Act No. 8492, Republic Act No. 9105, Republic Act No. 10066, and all other laws and issuances amending or citing as legal basis the same;

WHEREAS, Section 30 of Republic Act No. 11333 further provides that the transfer of these regulatory functions from the **NMP** to the **NCCA** shall be effected within two (2) years of its entry into legal effect, which occurred on July 31, 2019;

WHEREAS, the implementation of Section 30 of Republic Act No. 11333 necessitates the approval of an appropriate legal-binding instrument to provide for the orderly transfer of these regulatory functions from the NMP to the NCCA, hence the Memorandum of Agreement (MOA) between the NCCA and NMP;

WHEREAS, the efforts of the NCCA to establish the necessary organizational capacity and resources to assume and carry out these regulatory functions within the designated period are ongoing and, in recognition of this, it is agreed between the Parties hereto that the transfer of these regulatory functions would most appropriately be effected in two (2) tranches, to be provided for in the MOA;

NOW, **THEREFORE**, be it **RESOLVED**, as it is hereby **RESOLVED**, and in consideration of the foregoing premises, To **Approve** the **Memorandum of Agreement** (**MOA**) providing for the implementation of Section 30 of Republic Act No.11333, transferring the regulatory functions of the National Museum of the Philippines (NMP) to the National Commission for Culture and the Arts(NCCA), herewith attached as Annex C;

5.3 Request for Approval of the Guidelines of SUDI Awards (National Music Awards)

The board approved and adopted the Guidelines of the "SUDI" Awards (National Music Awards). SUDI awards is a National Music award that aims to recognize outstanding contributions of Filipino musical works, creators, institutions, and researchers across genres and modes of productions with the highest standard and artistic excellence. "SUDI" is an an Ilokano adjective meaning illustrious, renowned, celebrated, or famous suggested by the National Committee on Music.

[U]pon motion made and duly seconded, the Commission approved this *Resolution:*

Resolution No. 2020–334 Approving and Adopting the Guidelines of the SUDI Awards (National Music Awards)

WHEREAS, the SUDI Awards (National Music Awards) is a national music award that aims to recognize outstanding contributions of Filipino musical works, creators, institutions,

and researchers across genres and modes of productions with the highest standard and artistic excellence;

WHEREAS, the concept of the award was initially conceptualized and proposed by former NCCA chairman, Dr. Virgilio Almario. Thus, a technical working group was created and chaired by Mr. Noel Ferrer, under the recommendation and supervision of Chair Almario with the NCCA Committee on Music, National Artists for Music and National Music Industry Groups;

WHEREAS, the preparation of concept and preparatory works and research was approved with funding of ONE MILLION PESOS (PhP1,000,000.00) pursuant to Board Resolution No. 2020-179;

WHEREAS, the Technical Working Group prepared the concept, guidelines and implementation of the program with the Committee on Music and the name "SUDI", which is an Ilokano adjective meaning illustrious, renowned, celebrated, or famous was suggested by the National Committee on Music and said recognition has no cash award;

WHEREAS, the SUDI Awards is consistent with the Commission's mandate to extend recognition of artistic achievement through awards and grants and service to artists and cultural groups which contribute significantly to the Filipino's cultural legacy [Sec. 12 (a)(4)];

WHEREAS, for the year 2020, its launch year, 20 most outstanding musical achievements (whether artist, musical piece, journal, cultural worker, or institution, but not limited to) that defined the past decades will be given recognition;

WHEREAS, excellent and significant musical contributions (whether artist, musical piece, journal, cultural worker, or institution, but not limited to) shall be recognized annually in the succeeding years.

WHEREAS, the National Committee on Music and the Technical Working Group request and recommend adoption of the guidelines for the implementation of the SUDI Awards;

NOW, THEREFORE, be it **RESOLVED,** as it is hereby RESOLVED, To **Approve** and **Adopt the Guidelines of the SUDI Awards (National Music Awards),** herewith attached as Annex D.

WHEREAS, the Commission is mandated to support and encourage artistic creation within a climate of artistic freedom, develop and promote the Filipino national culture and arts; and preserve Filipino cultural heritage;

WHEREAS, the National Committee on Cinema in its memorandum to the Board of Commissioners dated 10 August 2020, requested and recommended approval of the cancellation and withdrawal of projects approved pursuant to Board Resolution Nos. 2020-076, 2020-077, 2020-078, 2020-079, 2020-084, 2020-088, 2020-089 and 2020-090, and to utilize the funding allocated to the said projects in the total amount One Million Six Hundred Ten Thousand Pesos (PhP 1,610,000.00) for a new project, "EKSENA: Cinema Quarantine";

WHEREAS, the project "EKSENA: Cinema Quarantine" aims to contribute to the development of Philippine cinema by curating an omnibus feature length film in the time of COVID-19 comprising of 12 short films from 12 filmmakers around the country;

WHEREAS, by virtue of Board Resolution No. 2020-335, the Commission approved the withdrawal and cancellation of several projects approved pursuant to Board Resolution Nos. 2020-076, 2020-077, 2020-078, 2020-079, 2020-084, 2020-088, 2020-089 and 2020-090;

NOW, THEREFORE, be it RESOLVED, as it is hereby RESOLVED, To Approve a *Grant* to *University of Saint La Salle, Inc.* for the implementation of the project, *EKSENA: Cinema Quarantine* in the amount of *One Million Six Hundred Ten Thousand Pesos Only (PhP 1,610,000.00)*, subject to availability of funds and issuance of Notice of Cash Allocation (NCA) from the Department of Budget and Management (DBM) and to applicable government accounting, auditing rules and regulations;

RESOLVED FURTHER, That the budget/funding of **PhP 1,610,000.00** shall be sourced from the budget previously approved and allocated for the projects withdrawn and cancelled per Board Resolution No. 2020-335.

- **WHEREAS**, Section 63 of the IRR of Republic Act No. 7356 provides that the ExeCon of each NC shall elect its officers: a Head, a Vice Head and a Secretary who shall be elected for a term of three years reckoned from January 1, 2011, thereafter, for as long as he/she remains a member of the NC, and shall not serve for more than two consecutive terms;
- **WHEREAS**, pursuant to Section 64 of the same IRR, the officers and members of the ExeCon shall be elected for a term of three years, reckoned from January 1, 2011, thereafter, for as long as he/she remains a member of the ExeCon, and shall not serve for more than two consecutive terms, to ensure broad representation among artists and cultural workers;
- **WHEREAS**, under Section 58 of the same IRR, the specific membership requirements, qualifications, criteria and composition of the NCs shall be approved and promulgated by the Commission through Board Resolution upon the recommendation of the respective national committees;
- **WHEREAS**, pursuant to Board Resolution No. 2019-329, dated 18 June 2019, "Approving the Membership Guidelines and Election Rules of the National Committee on Cinema (NCC)", the ExeCon of the National Committee on Cinema shall consist of 13 members and shall be composed of institutional, sectoral and regional representatives;

Annex B

ETHNOMEDICINE CATEGORY Guidelines

- 1. This document shall be known as the Gawad sa Manlilikha ng Bayan Guidelines on Ethnomedicine Category.
- 2. The guidelines are promulgated to prescribe the screening, selection, and vetting process of candidates for the Gawad sa Manlilikha ng Bayan under the Ethnomedicine Category.
- 3. This set of guidelines shall be interpreted in light of the declaration of policy of the State as set forth in Section 2 of R.A. 7355, that is, "to preserve and promote its traditional folk arts whether visual, performing, or literary, for their cultural value, and to honor and support traditional folk artists for their contributions to the national heritage by ensuring that the artistic skills which they have painstakingly cultivated and preserved are encouraged and passed on to future generation of Filipinos.

4. Definition of Terms:

- a) **Albularyo** refers to a general practitioner of all indigenous modalities of healing.¹
- b) **Babaylan** (Traditional Healers) refers to a person with knowledge in indigenous and/or Philippine belief systems, oral traditions and health practices, who uses the traditional medicine of the Indigenous Cultural Communities (ICCs)/ Indigenous Peoples (IPs) and/or other ethno-linguistic groups in the Philippines, including but not limited to, the *Ilocanos, Davaoeños, Cagayanons, Cebuanos, Tagalog, Bicolanos, Boholanos, Ilonggos, Kapampangan, Batangenos, Cavitenos, Negrenses*, et cetera.
- c) **Ethnomedicine** refers to a wide range of healthcare systems/structures, practices, beliefs, and therapeutic techniques that arise from Philippine Traditional Cultural Communities.
- d) **Herbal Medicine/Phyto Medicine** refers to finished, labeled, medicinal products that contains as active ingredients aerial or underground part/s of plant or other materials or combination thereof, whether in the crude state or as plant preparations. Plant materials include juices, gums, fatty oils, essential oils, and other substances of this nature. Herbal medicines, however, may contain excipients in addition to the active ingredients/s. Medicines containing plant material/s combined with chemically defined active substances, including chemically defined isolated constituents of plants, is not considered to be herbal medicines.

- e) **Hilot** refers to the science and art of the ancient Filipino healing grounded on the principle of balance of the physical elements, together with the mental, emotional and spiritual aspects of the person, with the use of manipulations and medicinal plants, for the prevention of disease and for the restoration and maintenance of health and wellbeing.²
- f) Manlilkha ng Bayan or National Living Treasure, refers to the traditional folk artists entitled to the recognition provided for R.A. 7355. As envision under the said law, this term shall mean a citizen or group of citizens engaged in any traditional art uniquely Filipino whose distinctive skills have reached a high level of technical and artistic excellence, and the knowledge and skills have been passed on to and are widely practiced by the present generation in his/her/their community with the same degree of technical excellence.
- g) **Traditional Cultural Community** are groups of people who share a cultural identity by self-ascription and ascription by others which can be based on language, history, values, and practices.
- h) **Traditional Folk Art** refers to expression of creativity and distinctiveness serving decorative, aesthetic, and/or utilitarian or socio-economic functions and traditional and folk artists commonly known for such works.
- i) **Traditional Medicine/Healing** refers to the sum total of knowledge, skills, and practices on healthcare, not necessarily explicable in the context of modern, scientific, philosophical framework, but recognized by the people to help maintain and improve their health towards the wholeness of their being, the community and society, and their interrelations based on culture, history, heritage, and consciousness.
- 5. To be a candidate for the Gawad sa Manlilikha ng Bayan under the Ethnomedicine category, an individual or group candidate must:
 - a) Possess a mastery of the tools and materials needed for the traditional folk art and be a maker of works of extraordinary technical quality;
 - b) Have consistently produced works of superior quality over significant period;
 - c) Have engaged in a traditional and folk art which has been in existence and documented for at least fifty (50) years;
 - d) Must have transferred and/or willing to transfer to other members of the community the skills in the traditional and folk arts for which the community has become nationally known.

However, a candidate who, due to age or infirmity, has left him/her/them incapable of teaching further his/her/their craft, may still be recognized provided that he/she/they must possess the qualifications as enumerated above.

6. The following are the basis of disqualification from being nominated to the Gawad sa

Manlilikha ng Bayan:

- a) Incumbent officials or members of the NCCA secretariat and national committees;
- b) Conviction by final judgment of a crime involving moral turpitude.
- 7. The scope of the category may cover but not limited to Traditional Healing, Herbal Medicine, and other health traditions and practices by different Traditional Cultural Communities. Considerations shall be made for adequate representation in geographic distribution.
- 8. The GAMABA Executive Council shall invite representatives from **Philippine Institute of Traditional and Alternative Health Care** (PHITAHC), **Department of Science and Technology** (DOST), **Philippine Medical Association**, and **Medical Anthropology experts** as members of the Council of Experts during the 1st Level of Deliberation as long as these representatives satisfy the qualifications stipulated in Section 10 of the revised IRR of R.A. 7355.
- 9. The GAMABA Executive Council shall conduct the selection of the candidates in the following manner:
 - a) The GAMABA secretariat, upon approval by the GAMABA Executive Council, shall announce the opening of nominations through media releases and sending of letters to qualified organizations inviting them to submit nominations.
 - b) Candidates may be nominated to under one subcategory of Ethnomedicine where the candidate made his/her most significant contribution.
 - c) The submitted nominations shall be reviewed by the GAMABA Executive Council and Secretariat for completeness of submitted documents.
 - d) Only nominees whose traditional medicine and healing practices documented under the Philippine Traditional Knowledge Digital Library on Health will proceed for the research and documentation.
 - e) Research and documentation teams will be tapped to do extensive research on safety, efficacy and cultural significance on the works of the candidate within a maximum of six (6) months:
 - f) A folio and a presentation for each nominee shall be prepared by the GAMABA secretariat from the output of the research and documentation;
 - g) The Council of Experts shall be convened for the first level review from which endorsement to the next level is expected;
 - h) The Ad Hoc Council of Expert shall meet to evaluate the endorsements from the first level for endorsement to the NCCA BOC.
 - i) The NCCA Board of Commissioners shall conduct the third level review of the nominees and a list of those endorsed shall be submitted to the Office of the President.
 - j) It is requested that the President of the Philippines issue a declaration for those confirmed as Manlilikha ng Bayan or National Living Treasure;
 - k) The NCCA shall organize the conferment of the award and a celebration in their community.

- 10. A member of the Council of Experts and AD HOC Panel of Experts who is related to a nominee up to the fourth degree of consanguinity or affinity shall inhibit himself/ herself from the deliberation process. The list of nominated members of the GAMABA Panel of Experts shall be submitted by the GAMABA secretariat to the NCCA Board for review and designation.
- 11. The GAMABA secretariat shall accept nominations in writing and with proper supporting documentation, and these will include:
 - a) A cover letter signed by the head or designated representative of the nominating organization;
 - b) A duly accomplished nomination form;
 - c) A detailed *curriculum vitae* of the nominee;
 - d) Three (3) latest colored photograph in high resolution of the nominee and nominee's works;
 - e) 20 to 30-minute video documentation on the work and skills of the nominee;
 - f) Any other document that might be required.
- 12. The guidelines shall take effect upon approval by the NCCA Board of Commissioners.

MEMORANDUM OF AGREEMENT

PROVIDING FOR THE IMPLEMENTATION OF SECTION 30 OF REPUBLIC ACT NO. 11333, TRANSFERRING TO THE

NATIONAL COMMISSION FOR CULTURE AND THE ARTS THE REGULATORY FUNCTIONS OF THE NATIONAL MUSEUM OF THE PHILIPPINES DESIGNATED TO IT UNDER SPECIFIC PRIOR LAWS AND ISSUANCES

This Memorandum of Agreement made and entered into at the City of Manila, Philippines on ______, by and between:

The NATIONAL COMMISSION FOR CULTURE AND THE ARTS, with office address at the NCCA Building, General Luna Street, Intramuros, Manila, represented herein by its Chairman, Mr. ARSENIO J. LIZASO (hereafter referred to as the NCCA);

- and -

The **NATIONAL MUSEUM OF THE PHILIPPINES**, with office address at the Old Legislative Building, Padre Burgos Avenue, Manila, represented herein by its Director-General, **Mr. JEREMY R. BARNS** (hereafter referred to as the "**NMP**");

WITNESSETH:

WHEREAS, Section 30 of Republic Act No. 11333, otherwise known as the "National Museum of the Philippines Act", provides for the transfer of regulatory functions from the NMP to the NCCA, specifically all regulatory functions as provided by Republic Act No. 4846, Presidential Decree No. 260, Presidential Decree No. 374, Presidential Decree No. 1109, Republic Act No. 8492, Republic Act No. 9105, Republic Act No. 10066, and all other laws and issuances amending or citing as legal basis the same:

WHEREAS, these regulatory functions can be generally categorized and described as follows:

- 1. Registration of Cultural Property, as provided by Republic Act No. 4846 as amended by President Decree No. 374, Republic Act No. 8492, and Republic Act No. 10066;
- 2. Relative to National Cultural Treasures and Important Cultural Properties, as provided by Presidential Decree No. 260, Republic Act No. 4846 as amended by President Decree No. 374, Republic Act No. 8492, and Republic Act No. 10066, authority and responsibilities over:
 - 2.1. Designation/declaration and declassification/delisting;
 - 2.2. Removal of the presumption of Important Cultural Property for cultural properties in general, and particularly over archaeological and traditional ethnographic materials;
 - 2.3. Placement of an official heritage marker;
 - 2.4. Protection, preservation, restoration and/or reconstruction, and related powers to issue a Cease and Desist Order, Compulsory Repair Order, exercise visitorial powers, deputize other government agencies, modify responsibilities among cultural agencies for the designation of cultural property, and enforce public accessibility by the general public and government representatives;

- 2.5. Regulation of the change of ownership and right of first refusal on the sale of national cultural treasures, and the first option of buying important cultural properties placed for sale;
- 2.6. Exportation, importation, and repatriation claims in cases of illicit export; and
- 2.7. Licensing and regulation of dealers and exporters of cultural properties;
- 3. Designation of Heritage Zones, as provided by Republic Act No. 10066;
- 4. Regulation to assist indigenous peoples in the preservation of their respective cultural and historical properties, as provided by Republic Act No. 10066;
- 5. Implementation of Republic Act No. 9105, the "Art Forgery Act of 2001", involving the creation and support of the Art Authentication Panel mandated therein; and
- 6. Regulation of archaeological exploration and excavation, anthropological research, and treasure hunting, and related powers to deputize the Philippine National Police and Armed Forces of the Philippines to protect, preserve, and facilitate the reporting of discovery of, archaeological sites, and to provide incentives and rewards for the reporting of newly discovered archaeological, historical and cultural sites, as provided by Republic Act No. 4846 as amended by President Decree No. 374, Presidential Decree No. 1109, Republic Act No. 8492, and Republic Act No. 10066;

WHEREAS, Section 30 of Republic Act No. 11333 further provides that the transfer of these regulatory functions from the **NMP** to the **NCCA** shall be effected within two (2) years of its entry into legal effect, which occurred on July 31, 2019;

WHEREAS, the implementation of Section 30 of Republic Act No. 11333 necessitates the approval of an appropriate legal-binding instrument to provide for the orderly transfer of these regulatory functions from the **NMP** to the **NCCA**, hence this Memorandum of Agreement; and

WHEREAS, the efforts of the NCCA to establish the necessary organizational capacity and resources to assume and carry out these regulatory functions within the designated period are ongoing and, in recognition of this, it is agreed between the Parties hereto that the transfer of these regulatory functions would most appropriately be effected in two (2) tranches, to be provided for in this Memorandum of Agreement.

NOW, **THEREFORE**, and in consideration of the foregoing premises and their covenants hereafter set forth, the Parties hereto agree as follows:

1. A first tranche of regulatory functions shall be formally transferred from the **NMP** to **NCCA**, with such transfer to be officially effective on January 1, 2021.

This first tranche shall comprise all regulatory functions enumerated and described above under numbers 1, 2, 3, 4, and 5, as provided by Presidential Decree No. 260, Republic Act No. 4846 as amended by President Decree No. 374, Presidential Decree No. 1109, Republic Act No. 8492, Republic Act No. 9105, and Republic Act No. 10066, covering: 1) registration of cultural property; 2) regulation of declared National Cultural Treasures and declared or presumptive Important Cultural Properties; 3) designation of Heritage Zones; 4) regulation to assist indigenous peoples in the preservation of their respective cultural and historical properties; and 5) creation and support of the Art Authentication Panel and overall implementation of the Art Forgery Act of 2001.

2. A second tranche of regulatory functions shall be formally transferred from the **NMP** to **NCCA**, with such transfer to be officially effective on July 1, 2021.

This second tranche shall comprise all regulatory functions enumerated and described above under number 6, as provided by Republic Act No. 4846 as amended by President Decree No. 374, Presidential Decree No. 1109, Republic Act No. 8492, and Republic Act No. 10066, covering: 6) regulation of archaeological exploration and excavation, anthropological research, and treasure hunting, and related powers to deputize the Philippine National Police and Armed Forces of the Philippines to protect, preserve, and facilitate the reporting of discovery of, archaeological sites, and to provide incentives and rewards for the reporting of newly discovered archaeological, historical and cultural sites.

- 3. The **NMP** shall transfer all necessary files and related materials, or copies thereof, to the **NCCA**, as the latter may need or require in line with its assumption of the regulatory functions of the **NMP** as covered by Section 30 of Republic Act No. 11333 and this Memorandum of Agreement.
- 4. The NMP shall request and facilitate the transfer by the **Department of Budget and Management (DBM)**to the **NCCA** of all pertinent unfilled plantilla items from the existing Cultural Properties Regulation Division of the **NMP** as may be agreed between the Parties hereto and the **DBM**, may be required by the **NCCA** in line with its assumption of the regulatory functions of the **NMP** as covered by Section 30 of Republic Act No. 11333 and this Memorandum of Agreement.
- 5. In its execution of regulatory functions after their transfer from the NMP, the NCCA shall, as provided by Section 30 of Republic Act No. 11333, have the right to enjoin the NMP to provide all technical and expert assistance within its mandated competencies as the NCCA may require.
- 6. This Memorandum of Agreement shall represent and serve as the primary legally-binding implementing measure of Section 30 of Republic Act No. 11333, and shall enter into effect upon its signing after prior authorization to do so has been given to the Executive Director of the **NCCA** and the Director-General of the **NMP** by the Board of Commissioners of the **NCCA** and the Board of Trustees of the **NMP**, respectively.
- 7. This Memorandum of Agreement cannot be amended or terminated by the Parties hereto except in the event that Section 30 of Republic Act No. 11333 is legally amended, repealed or held to be unconstitutional or invalid.
- 8. In the event of a dispute arising out of the performance or the interpretation of this Memorandum of Agreement, the Parties hereto undertake to take all possible measures to settle it amicably.

ANNEX D

NATIONAL COMMISSION FOR CULTURE AND THE ARTS Subcommission on the Arts

SUDI AWARDS GUIDELINES

The National Commission for Culture and the Arts (NCCA) SUDI Awards is a National Music award that aims to recognize outstanding contributions of Filipino musical works, creators, institutions, and researchers across genres and modes of productions with the highest standard and artistic excellence.

For the year 2020, its launch year, the twenty (20) most outstanding musical achievements (whether artist, musical piece, journal, cultural worker, or institution, but not limited to) that defined the past decades will be given recognition.

In the succeeding years, excellent and significant musical contributions (whether artist, musical piece, journal, cultural worker, or institution, but not limited to) shall be recognized annually.

Eligibility

1.1 The award is for all Filipino Composers or songwriters; Performing entity/groups; Researchers/writers and other music projects; and music compositions/works, except to the officers and members of the NCCA Secretariat, the incumbent Executive Council (ExeCon) Members of the NCCA Committee on Music (NCM), and the current Technical Working Group for the SUDI Awards.

Honors

2.1 The winners of the SUDI Award shall receive a trophy designed for the SUDI Awards. They shall receive the rank and title of SUDI Awardee.

• Composition of Groups Involved in the SUDI Awards Selection Process

- 3.1 The SUDI Award Secretariat will be organized to manage the SUDI Awards.
- 3.2 The Organization of Experts, who shall serve as consultants for the SUDI Awards, shall be composed of the following members (maximum of 7 members including the project director):
 - a) National Artist for Music;
 - b) Head of the National Committee on Music;
 - c) Representative from Organisasyon Ng Pilipinong Mang-aawit;
 - d) Representative from the Music Business Sector;
 - e) A active practitioner/music artist;
 - f) The Project Director and proponent of this awards who is a media representative and the Founding Member of the Pinoy Playlist Music Festival who was tasked to constitute this organizing body.
- 3.3. A credible Jury from the Music Sector selected from the pool of experts recommended by the organization of experts shall be formed. The organization shall recommend a maximum of 11 members for the Board of Jury (including the chairman of the Jury). The Board of Jury members shall always remain an odd number.

The SUDI Awards Board of Jury shall be selected based on the following criteria:

- a) Should have achieved authority, credibility and track record in the field of Philippine music;
- b) Should have extensive knowledge of their discipline(s) and understanding of Philippine music and culture;
- c) Must be willing to sign a non-disclosure statement in order to safeguard the confidentiality of the deliberations.
- 3.4 A Research Group will be formed by the SUDI Awards Technical Working Group. The Research Group shall accomplish its task within three (3) months. The main objectives are:
 - a) Create a directory of the SUDI Awards;
 - b) Produce a comprehensive collection of body of works and relevant data for each nominee which will include (but not be limited to): curriculum vitae, video and recording documentation relating to the nominee, other relevant contributions;
 - c) Present useful data to validate nominations. E.g.: audience reception, music sales/consumer engagement, national and/or international recognition, research impact and relevance, etc.

• Criteria for Selection

The NCCA SUDI Award shall be given to nominees who have met the following criteria:

- 4.1Living nominees who are Filipino citizens at the time of nomination and at the awarding, as well as those who died after the establishment of the award in 2020 but were Filipino citizens at the time of their death.
- 4.2Nominees who had a definite contribution to the music landscape of that particular decade or year and has brought the Filipino people to a greater appreciation and understanding of Philippine music and culture.
- 4.3Nominees who achieved excellence and empowered people in the sector, thereby adhering to the highest standards of music creation, research, and performance.
- 4.4Nominees who received accolades through positive reviews or write-ups from peers and critics and awards from local or international award-giving bodies, and refereed/featured in local and international conferences/festivals and journals/published works. And whose works have been repeatedly performed in all venues and parts of world.

• Screening and Selection Process

5.1A representative from the NCCA National Committee of Music, the organization of experts, and SUDI Awards Secretariat will regularly meet to identify/shortlist prospective nominees/awardees composed of Filipino Composers or songwriters; Performing entity/groups; Researchers/writers and other music projects; and music compositions/works who have made valuable contributions in the field of music for the past decade/this year.

- 5.2The First Deliberation panel composed of the SUDI Awards Technical Working Group shall shortlist the final nominees based on the Research Group's gathered data. After which, the nominators shall provide an extensive and comprehensive dossier for each shortlisted nominee. The Research Group will assist in verifying, validating, and evaluating the quality, true value, and significance of works according to the criteria.
- 5.3 The Final Deliberation panel shall be composed of jury members selected by the SUDI Awards Technical Working Group. Pertinent documents along with audio-visual presentations for each nominee shall be submitted to the jury for their review and final decision. The Research Group will further assist in verifying, validating, and evaluating the quality, true value and significance of works according to the criteria.
- 5.4 The decision of the Board of Jury is final and irrevocable. The SUDI Awards Technical Working Group, reserves the right to make any changes deemed necessary to any part of the award prior to the decision of the Board of Jury without any prejudice to the nominees.
- 5.5 The Board of Jury can make special citations for noteworthy accomplishments.
- 5.6 The list of winners shall be submitted to the SUDI Awards Secretariat.
- 5.7 The Organization of Experts and the Board of Jury will recommend the awardees to the NCCA Board of Commissioners for confirmation. By this time, the NCCA, through its representatives in all the committees and the secretariat, would have ascertained that the process was efficiently observed and that the final awardees will be concurred by the NCCA Board of Commissioners.

• Presentation of the Awards

- 6.1 The selection and conferment of the SUDI Award shall take place annually.
- 6.2 The SUDI Award shall be conferred on any appropriate date in fitting ceremonies to be organized by the SUDI Awards Secretariat.
- 6.3 The trophy of the SUDI Award and citation shall be given to the awardee during the conferment ceremony.

• Amendment/Revision

7.1Any amendment/minor revision on the general guidelines shall be approved by the Chair through the Executive Director, upon review, recommendation and endorsement by the SUDI Awards Technical Working Group through the Subcommission on the Arts (SCA). The Board shall be informed of any update for the implementation year, as well as the winner/s for the covered year.
