NCCA STRATEGIC PLAN 2020 - 2022

NCCA Achievements: 2017 - 2019

Cluster 1 - Supporting the National Priorities on Culture

- The study to clarify Filipino values for national development under the NCCA is currently in
 its final stages of validation and results will be available on the last quarter of 2019
- The corpus of Filipino values study will be used to update the DepEd core values curriculum, as well as the Civil Service Institute's Public Service Values Program
- The Philippine Cultural Statistics Framework is being implemented by the NCCA and the Philippine Statistics Authority (PSA) to generate sound cultural statistics in aid of policy and programming toward a high-trust society
- The UNESCO 2005 Convention, a legally-blinding international agreement on the protection and promotion of the diversity of cultural expressions, is also expected to be ratified in the Philippines within this year.
- Funded the establishment of Cultural Hubs in Region VI, VII, and XI.
- The NCCA continues to support long-established awards and created new ones such as National Artist Awards with 73 recipients, of which 11 are living; GAMABA with 16 recipients, of which 9 are living; Ani ng Dangal with 590 recipients; and Dangal ng Haraya with 2 recipients.
- To date, the total number of cultural properties registered in the Philippine Registry of Cultural Property (PRECUP) is 7,628. More than a hundred LGUs have already been coordinated and that includes giving them workshops regarding cultural mapping.
- The NCCA has established a Cultural Mapping Program to help LGUs identify and account their cultural properties. To date, the NCCA has assisted 38 LGUs nationwide.
- The NCCA provided opportunities to approximately 5,196,361 number of public school students, government employees, and communities to participate in cultural events.
- The NCCA reached 271,122,037 number of audience in quada-media (NCCA website, publications, TV, and other media platforms).
- To further celebrate culture and arts, the NCCA spearheaded National Celebrations such as the National Arts Month, National Heritage Month, National Literature Month, Independence Day, Indigenous Peoples Month, Buwan ng Kalutong Filipino, Dance Xchange, Linggo ng Musikang Pilipino, and Museum and Galleries Month.
- In response to the need of national development through culture and arts, the NCCA has funded a total of 1,226 projects and programs from 2017 to 2019.
- In cooperation with the DFA, the NCCA assisted in drafting and implementing of 55 cultural exchange agreements.

Cluster 2 - Responding to the Marginalized and Vulnerable

 Established 16 Knowledge Development Centers and SLTs nationwide, and 36 Sentros Rizal overseas, and 6 Institute of Living Traditions (ILTs) nationwide.

Cluster 3 - Broadening Reach and Access

- The NCCA has established closer linkages with LGUs to align efforts on cultural preservation, inventory of cultural properties, cultural mapping, and other culture-related activities. It has been included in regional development councils for cultural concerns.
- Provision of capacity building and knowledge development support for LGUs and the public has been strengthened
- 609 LGUs with Local Culture and Arts Council (LCAC)
- The NCCA has been continuously cooperating with the legislative offices, as well as with OP
 for the review of 49 legislative related policies
- Bill creating the Department of Culture (DOC) still pending in Congress. This legislation
 seeks to respond to several structural weaknesses of the culture sector by: (a) acquiring the
 mandate and resources to implement initiatives from national to local levels, (b) rationalizing
 the overlapping functions among existing agencies, and (c) asserting the regulatory powers as
 prescribed by law.

Cluster 4 - Strengthening NCCA Human and Organizational Capacity

- The NCCA has officially received the ISO 9001:2015 Certification for the Administration of NEFCA-Supported Competitive Grants on January 14, 2019. The National Endowment Fund for Culture and Arts (NEFCA) has its scope limited to services directly affecting the public through grants.
- The Secretariat is being reengineered to provide the NCCA and grants beneficiaries with more project development and administrative support. The creation of new offices / divisions is being proposed to meet the thrusts of the NCCA.





WHEREAS, the Chairman as the *de facto* Minister of Culture of the Philippines, is regularly invited to meetings and events among Ministers of Culture;


WHEREAS, the Chairman's presence is specifically sought at such meetings to deliver a message, a relevant paper or country statement/position on a given topic, and/or participate in discussions or decisions leading to the signing of Official Statements or Agreements;

WHEREAS, the Chairman due to other commitments and simultaneous engagements, is constrained from attending all such meetings and events,

WHEREAS, in the absence of the Chairman, the organizing party requests for an equally high level official of the same stature as his counterparts in the meetings;

WHEREAS, in order to ensure representation of the Commission in Ministerial meetings and relevant international engagements, the International Affairs Office-Sentro Rizal recommended that an alternate of the Chairman from the Heads of the Cultural Agencies be designated whose function will be akin to that of a Vice-Chairperson;

RESOLVED FURTHER, That in the absence of the NHCP Chairman, the NCCA Chairman shall designate his alternate from among the heads of the cultural agencies;

RESOLVED FINALLY, That the designation of an alternate from among the ranks of heads of cultural agencies does not preclude the Chairman's prerogative to assign another representative from the Board of Commissioners, Executive Councils of the National Committees, or other authorities when an event call for a specific area of expertise.
