Subject: Cease and Desist Order Against the Demolition of the Old Capitol Theatre Building

Dear Mr. Cuanson,

Greetings from the National Commission for Culture and the Arts (NCCA)!

This is in reference to the reports we received regarding the complete demolition of the Capitol Theatre Building, a cultural property protected by R.A. No. 10066 against demolition or modification.

According to our source, your onsite contractor said that the "tower relic" is included in the total demolition of the existing structures of the Capitol Theatre. Also, the pictures forwarded to us yesterday, 16 August 2022, already shows considerable damage done to the tower due to the demolition.

As mentioned in our letter dated 09 July 2019, this Commission reiterated the previously approved and agreed *in-situ* bracing methodology which is the best approach to preserve the façade of the "tower relic". You have likewise been advised by the Technical Working Council to revisit your design and/or methodology (architectural and structural) to adapt the proposed development to the existing structure. Any deviation from the aforementioned must be first evaluated and cleared and/or approved by this Commission.

Considering that no development plan or new methodology has been submitted to and approved by the NCCA, the ongoing demolition of the old Capitol Theatre Building is therefore done in violation of Section 48(a) of R.A. No. 10066. Moreover, by virtue of Section 25 of R.A. No. 10066, **Ascott Resources and Development Corporation** is hereby **ORDERED** to **CEASE AND DESIST** from further demolishing the old Capitol Theatre building and enact safety measures to ensure the integrity of what remains of the subject cultural property.
